The video that you submit (including all IP rights) will be kept, retained and owned by the Society. Your profile photo will be required should you qualify as one of the Finalists or proclaimed as the Winner.

The Winner will receive a trophy which e/she may keep and retain for a period of one year or until the winner of the next similar challenge is announced, whichever is the earlier.

from the data subject/owner that you may use the personal/clinical data of the data subject/owner in accordance with the disclosure matter, and (iii) the use of the personal/clinical data of the data subject/owner complies with the relevant policies of your employer, such as the internal policies for the use and management of clinical data /medical record data owned by hospital.

#### Privacy Notice and Consent

With your consent, the Company will collect, use, and process your Personal Data, including your profile photo, and Material for the following purposes:

- 1. Your registration and participation in the Event, including evaluation and assessment of the Material, consisting of the edited video of the laparoscopy surgery you performed.
- 2. For promotional and educational purposes of the Event in various materials and media, including Event announcements and communication to healthcare professionals for medical / scientific programs; and
- 3. Event-related and other administrative services.

A. Information Collection. With your consent, the Society will use, may edit and post or publish the Personal Data and Materials, in whole or in part, in varying forms and media, in connection with whatever copy, graphics, or images the Company may choose, at its sole discretion, without restriction as to extent, range, frequency, or area of use. The Company may make the Materials, in original or edited version, in whole or in part, accessible to health care professionals (HCPs) for the purpose of promoting the Event through offline and online channels which include but are not limited to hard copy of Materials, chat, email and Society Website (https://www.pscrs.com.ph). The Society will use and process your Personal Data and relevant portions of the Materials in accordance with its Privacy Policy.

B. Disclosure of Information. We may also disclose your Personal Data and Materials to unaffiliated third parties, but only to [i] service providers that we use to support our business, such as technology and digital/ marketing service providers, and with which we have a contract in place, and [ii] third parties engaged directly or indirectly in the organization and management of the Event.

C. Your Privacy Rights. Subject to certain exceptions permitted by law, you may request to review, or request correction, deletion, blocking, data portability or restriction of our use of your Personal Data and Materials. You may withdraw your consent at any time; you acknowledge that your withdrawal of consent shall not affect the use and processing of all or any part of the Personal Data and Materials done or effected prior to the date that we receive your notice.

D. Data Retention. We will retain your Personal Data and Materials for as long as needed or permitted in the light of the purpose(s) for which they were obtained. The criteria used to determine our retention periods include: (i) the length of time we have an ongoing relationship with you and provide the service to you; (ii) whether there is a legal obligation to which we are subject; and (iii) whether retention is advisable in light of our legal position (such as in regard to applicable statutes of limitations, litigation, or regulatory investigations). We will dispose of or discard your Personal Data and Materials in a secure manner that would prevent further processing, unauthorized access by or disclosure to any other party or the public. You understand that wherever your Personal Data and Materials or any part thereof are retained and stored, they will be kept confidential and secured.



F. Security measures. We respect the importance of confidentiality and security of your personal data. We will always implement the appropriate organizational, technical, and administrative measures to ensure the integrity, availability, and security of your personal data, that are consistent with industry practice.

G. If the personal information you provide to the Society includes personal information of a third party other than yourself, you shall make that third party aware in an appropriate manner that his or her personal information will be provided to the Philippine Society of Colon and Rectal Surgeons, Inc. for collection, processing, use, and international transmission within the scope of this privacy notice. You shall also make the third party agree that the Philippine Society of Colon and Rectal Surgeons, Inc. (or the person to whom the Society provides the information) may process, use and transmit the third party's personal information internationally.
